

1.0 Project Background

I.I Objective

The Project Development Objective (PDO) is to improve the management of ecosystems in selected locations in Sri Lanka for conservation and community benefits. The project is deigned to achieve few specific objectives such as, enhanced biodiversity protection, livelihood improvement of communities living adjacent to the Protected Areas (PAs), developed strategies for human-elephant co-existence, developed pilot level landscape management plans and institutional capacity development of implementing agencies, Forest Department (FD) and Department of Wildlife Conservation (DWC).

1.2 Project Description

The Project will be financed through a US\$ 45.0 million International Development Association (IDA) Credit. Following table illustrates the project costs by major components of the project (Table I).

Component I (Pilot landscape planning and management) will facilitate planning and implementation of activities in two selected biodiversity rich landscapes (a wet zone and a dry zone as a model exercise) with unique ecological, cultural and socio-economic characteristics.

Component 2 (Sustainable use of natural resources and human-elephant co-existence) will promote productive biodiversity compatible livelihood activities to reduce forest destruction. Planning the use of natural resources and aiming to transform Human Elephant Conflict into Human Elephant Co-existence by addressing the needs of the communities living in close association with the wildlife in the adjacent areas of PAs. Component 3 (Protected area management and institutional capacity) will support demand-driven interventions in PAs in

accordance with the Fauna & Flora Protection Ordinance, and Forest Ordinance; strengthen institutional capacity and investment capability for conservation and management; and provide assistance to develop the long-term financial sustainability for managing PAs. **Component 4** will finance the Project Management Unit (PMU) and Implementing Agencies (FD & DWC) in project implementation, project management, technical assistance and monitoring & evaluation.

The project has designed to implement from 2017-2021. Executing agencies of the project are Ministry of Mahaweli Development and Environment and Ministry of Sustainable Development and Wildlife. Forest Department (FD) and Department of Wildlife Conservation (DWC) are responsible to implement the activities. Wildlife living in and around the PAs, communities living adjacent to the PAs, families facing human-elephant conflict adjoining the PAs, institutes responsible for natural resources management and stakeholders in eco-tourism industry are the main beneficiaries of the project.

Two separate workshops for both Implementing Agencies were organized by PMU to finalize the Action Plan for 2018 with the participation of key officials of DWC and FD. Accordingly, the Budgetary Allocations of 2018 for each component by Implementing Agencies are illustrated as follows.

2.0 Physical progress

2.1 Component I - Pilot Landscape Planning and Management

Component I is aimed at preparing Pilot Landscape Management Plans for two (2) selected sites in Dry Zone (DZ) and Wet Zone (WZ). Sites selection criteria were developed by the PMU and approved by the Expert Committee and the Technical Review Committee appointed for the Component 01. Based on these criteria, two project sites were selected ie; (1) Hurulu-Anawulundawa-Kawdulla complex (Mahaweli Basin) in Dry Zone (DZ) and (2). Singhraja Forest Complex (Rakwana Range) in Wet Zone (WZ).

Primarily Stakeholder Analysis has been carried in 2017 to identify main, secondary and tertiary stakeholders of the landscape who are operational and important in planning. The scope of the pilot landscape planning process was discussed in the workshop. Besides that, Regional Planning Committee meeting was held at Habarana and Stakeholder meeting was held at Trincomallee. Hotel sector has been identified as one of the key stakeholder therefore, a meeting with members of Tourist Hotel Association was held at Habarana on 23rd March 2018., to discuss the matters pertaining to Landscape Planning and potential hotel sector involvement in land restoration. A working group consisting of Project Director/ESCAMP, Coordinator/LMP, representative from WB, FD and DWLC were appointed to expedite and steer the planning process. This committee meet biweekly and discuss issues related to the Component.

Two consultants namely Sociologist and Land Use Specialist have been hired and currently they are carrying out their field work. In addition, Biodiversity Specialist has been hired and commenced work. Sociologist has developed a Social Survey Questionnaire and currently under survey in 124 Grama Niladari Divisions (GND) covering 14 Divisional Secretaries Divisions (DSD) in Anradapura, Pollonnaruwa and Trincomallee district. Currently 75 % of the survey has been completed. Apart from that to verify and gather the important information which are unable to collect through a questionnaire survey, 2 Focus Group Discussions (FGDs) were conducted in Kakirawa DSD. Another two FGDs will be held in Trincomalee District during April, 2018. Fifteen digital maps have been developed by the Land Use Specialist and basically, these maps will cover the different land use patterns/types of the project area.

A booklet on Landscape Planning which was prepared by the PMU distributed among field officers of relevant government institutions to provide technical information and create awareness on this component.

2.2 Component 2(a) - Sustainable Use of Natural Resources for Livelihood Enhancement

2.2.1 Overall

Component 2(a) will establish livelihood enhancement interventions as secondary income generating sources among communities living adjacent to PAs. Biodiversity-friendly and climate-smart existing or new livelihood options will be developed through participatory Community Action Plans (CAPs). It has planned to enhance livelihood options of 10,000 households by closing phase of the project. Participatory Rural Appraisals (PRAs) are done in selected villages to assess the livelihood needs of communities.

Awareness programs on this sub-component were conducted by both implementing agencies to create awareness among their officers who are working in project sites. The main objective of these programs were to streamline the field implementations with project's Action Plan 2018. The Community Action Plans (CAPs) prepared by field officers were revised and further developed by senior staff for improvement of the Micro-Plans and the Sub-Project Proposals. Also the awareness programs were conducted targeting benefitted communities by both implementing agencies. Further, the livelihood development assistances were given for few number of selected families during this quarter.

As guided by the Technical Review Committee (TRC) of this sub-component, identification of innovative alternative livelihood options for the target communities is continued by both implementing agencies. Number of training programs for CBO members were conducted by the FD in Polonnaruwa, Anuradhapura and Rathnapura districts. Further, PMU has appointed a short-term consultant as a Community Development Specialist to support for both Departments to strength the capacity on community management on livelihood development. Also PMU has organized to conduct a baseline assessment including the assessing of needs on innovative livelihood options. Data collection tools of this assessment have been finalized with the comments of senior staff of both Departments. It is expected to commence the data collection by third week of April 2018. Further, the PMU has drafted the monitoring indicators for this sub-component and has been shared with both Departments for further improvement. The proposed baseline assessment will assess the baseline values for these indicators and the

impact from project interventions will evaluate through Independent Periodic Evaluations which have been planned to conduct annually.

2.2.2 Progress of FD activities

Sub-project proposals which are based on the findings of CAPs from all project sites of FD have been cleared and approved for implementation. FD has conducted 09 community awareness programs at Matara-Sinharaja (02 programs) and Mathale-Knuckles (07 programs). In addition to that 05 trainings on viable livelihood options were conducted for community members just adjacent to the Hurulu Forest Reserve. More than 400 families have been benefitted through this awareness creation. Two training programs were conducted on the preparation of CAPs, writing proposals, participatory development, livelihood development, gender and ESCAMP and assessing training needs for capacity building etc. with the participation of 60 officers such as Range Forest Officers, Extension Officers and Field Assistants by the Community Development Consultant of the PMU.

Two Community Halls which are located near the buffer zone of Galle-Kanneliya Forest Reserve were renovated. Further, a comprehensive training program on 'Home Staying' was also conducted targeting 18 families adjacent Galle-Kanneliya Forest Reserve. A Forest Protection Committee (FPC) was established for Matara-Sinharaja Forest Reserve and firefighting tools were also provided to the committee members. FD is developing project-site specific criteria for beneficiary selection on livelihood development. A committee consists with key informants (Development Officers, Grama Niladhari Officers, Agriculture Research Assistants, Religious Leaders and School Teachers etc.) has been appointed to select beneficiaries adjacent Matale-Knuckles Forest Reserve. That committee have been identified 350 families to develop their home gardens.

2.2.3 Progress of DWC activities

Already prepared five CAPs for selected villages adjacent to Bundala National Park (NP) have been revisited by relevant senior staff members of the Department. Accordingly, five Micro-Plans prepared for such villages have been updated. Based on the micro-plan developed for Koonwalana, Yahangala-East and Nadigamwila villages, the sub-project proposals have been submitted by DWC to PMU. These sub-project proposals are activity based and it has proposed to implemented only an activity. Accordingly, construction of an Eco-Friendly children park, a water purification plant and establishment of catering services have been

proposed. All these activities will be implemented through a participatory approach and almost all target community members will be benefitted.

A training workshop on Micro Plans and Proposal Writing was conducted on March 2018 at the Community Education Centre in Malabe, for the park wardens and community outreach officers attached to the Department. Around 25 participants from Anuradhapura, Polonnaruwa, Uwa, Southern, Eastern, Wayamba and Puttlam divisions attended that workshop. Community consultation and mobilization, new PRA techniques, problem analysis, project partners and beneficiaries and proposal writing etc. were discussed at the training. This training was conducted by the Community Development Consultant hired by the project.

2.3 Component 2(b) - Human-Elephant Co-existence for Livelihood Protection

Component 2(b) is financing the scaling up successful Human-Elephant Coexistence (HEC) pilot projects within high Human Elephant Co-Existence areas. Activities of this component will be implemented by DWC and related community organizations.

A component coordinator for this sub-component was also hired by the PMU and commenced his work on March 2018.

The procurement of Radio Collars is in progress. Originally it had planned to complete this procurement by end of March 2018. However, the procurement process was delayed due to some technical reasons. These collars will be received to DWC by first week of May 2018. A Technical Consultant to provide guidance for preparation of Lunugamwehera Elephant Holding Ground (EHG) has been hired. Primary investigation and survey on 05 Water Tanks within the boundary of EHG have been completed. The estimations to construct 04 Causeways have been completed. Tender documents for jungle cleaning in the demarcated service road being prepared and it has planned to advertise by the last week of April 2018. The designing and cost estimations of Special Fence Posts were also completed with the technical inputs of the Technical Consultant. Estimation to construct 05 medium size tanks (Digampelessa wewa, Kiupitiya wewa, Dangahawewa, Nugewewa and Watawanayaya wewa) within the EHG were also completed by the Technical Officers appointed by the PMU.

The Questionnaires Survey on elephant presence and absences, which has planned to conduct in parallel to the Country Wide Elephant Survey will be commenced on April 2018. Two workshops have been scheduled for all ADs of the Department related to the above mentioned Survey.

A training program on HEC was successfully conducted at Mahawa DSD (Pahalagama village) in Kurunegala district and 40 DWC officers were participated for the training program representing all DWC regions. Also 06 awareness programs on this sub-component have been conducted by the Department and field level officers such as Rangers, Range Assistants and Wildlife Guards were participated. Accordingly, it has been planned to conduct separate awareness programs targeting Grama Niladhari Officers, Samurdhi Officers, Development Officers, Agricultural Research Assistants and Agrarian Development Officers in selected DSDs in Kurunegala and Anuradhapura districts. Ten Villages have been identified in both

Kerunegala & Anuradhapura districts to construct Village and Agro Fences. Preparation of cost estimates to procure equipment related to this activity is in-progress.

2.4 Component 3(a) - Protected Area Conservation and Management

This sub-component will support to habitat improvement for protected areas manage by both FD and DWC. Accordingly, funds will be made available for preparation of Protected Area Management Plans (PAMP) where needed and implementation of existing PAMPs for priority PAs. Priority PAs in the DWC and FD PA network are eligible for support under this sub-component, covering terrestrial, marine and wetland PAs.

2.4.1 Progress of FD activities

FD has done following actions on each main activity listed in the Action Plan 2018.

2.4.2 Progress of DWC activities

DWC expects to recruit a Technical Consultant for reviewing, updating and preparation of PAs' Management Plans. The procurement process of this consultancy is in-progress. According to the approved sub-project proposal on 'Rehabilitation of Old Cascade System', the completion of the preparation of cost estimations to rehabilitate the Tanks and Earthen Ponds (water halls) is in-progress. Based on the completed cost estimates, bids were called to rehabilitate 12 Small Tanks and 04 Rock-Ponds were advertised and the bid evaluation by TEC is in progress. DWC expects to award the contracts by mid-April 2018. Further, the estimation works were completed to rehabilitate 03 medium tanks, namely Komawewa in Yala Block I and Korawak wewa and Arangamuwe wewa in Yala Block II. According to the proposal mentioned above, the surveying of 11 Water Holes have been completed by the Technical Officers appointed by the PMU. They expect to complete the estimations by end of April 2018.

Basic training to establish the base-stations to support SMART Patrolling at selected 07 NPs was completed during 2017. Accordingly, the procurement of computers and other related SMART devises for base stations in 7 NPs in Uva, Southern and Eastern regions were completed. Field data collection to set-up the SMART patrolling in Yala and Udawalawa NPs have been completed. The data collection through the SAMRT devices is in-progress. Patrolling data will be collected during the first semi-annual period 2018. After analyzing the data, DWC expects to develop plans to expand the system to other PAs' as well.

DWC expects to improve Udawalawa NP and Yala-Lunugamwehera Complex under Habitat Management interventions during 2018. Accordingly, Invasive Aliens Species (IAS) Management Plans have been submitted to the PMU. Thus, separate Expert Committee for the above has been appointed. According to the IAS Management Plans submitted, its estimated 400ha to remove IASs in Udawalawa NP and 200ha in Yala-Lunugamwehera Complex. The total extents will be clustered to minimize the implementation issues and for evidence based monitoring purposes. The extent of each cluster will be 50ha. The

Environmental Safeguard Issues in both places were evaluated by the Safeguard Team of PMU and recommended the mitigation issues to enhance the implementation.

However, DWC expects to provide separate IAS Management Plan for 400ha in Lunugamwehera NP under the implementations of EHG. That plan will be submitted separately to the PMU.

A sub-project proposal for 'Developing, Improving and Rehabilitation of PA Management Infrastructure' is developing by DWC and it will be submitted to PMU by end of April 2018. Further, DWC has drafted two separate proposals on 'Forest Die-Back Issues' within NPs, namely; (I) Restoration of degraded dry forests in Bundala, Lunugamwehera and Yala (Block I) NPs (2) Overcome of forest die-back in Horton Plains NP. These proposals will be submitted to PMU by May 2018 for approvals.

As requested by DWC, a 'Rapid Social Assessment' in Baduwela region in Gal-Oya NP was conducted by the PMU. The prime objective of this assessment was to identify the social economic impacts, risks and opportunities of the propose demarcation works and to help avoid, minimize and where residual impacts remain to the affected communities. The report of this assessment has been completed and submitted to the WB for their comments. Based on the comments, some additional information has to be collected by the PMU on encroachment issues. An another separate assessment on 'Indigenous People' living in Gal-Oya NP (Rathugala area) was also conducted by the PMU. The final report of this assessment is also completed and submitted to the WB.

2.5 Component 3(b) - Nature-based Tourism in Protected Areas

This sub-component will support to improve the nature based tourism infrastructure and services of priority PAs of DWC and FD.

Project Steering Committee (PSC) was endorsed to hire an individual consultant to develop Systematic Nature Based Tourism Plans for 4 priority PAs of DWC and FD. Accordingly, international EOIs were called by the PMU and recruited Mr. Matthew Humke. He is a Sustainable Tourism Consultant who is having about 20 year experiences in Latin America, the Caribbean, Africa and Asia developing sustainable tourism as a tool for poverty alleviation and biodiversity conservation. He commenced his first country visit in line with his contract and visited following PAs to carry out situation analysis on some key factors such as Market Demand, Attraction Inventory, Infrastructure and Services, Supply and Competitiveness, Human and Institutional Capacity and Environmental Considerations etc.

- Knuckles Forest Complex (Kandy and Mathale Regions)
- Sinharaja Forest Complex (Rathnapura and Matara Regions)
- Udawalawa National Park
- Bundala National Park

In addition to that, he made a visit to Yala NP to carry out a brief 'Carrying Capacity Assessment' with the assistance of DWC staff. Based on the information collected, the consultant may develop draft Nature Based Tourism Plans (NBTPs) for above mentioned PAs. The consultant will do the second country visit to gather feedback to be incorporated into final versions of the NBTPs. His final visit to conduct in-depth training with a variety of stakeholders located within the proximity of each protected area to develop sustainability best practices and guidelines for better Nature Based Tourism. After completion of his first field visit he shared his findings and recommendations to the FD and DWC to obtain their views.

2.5.1 Progress of FD activities

Nine sub-project proposals of the FD has cleared to implement the rehabilitation and improvement of tourism related infrastructure. Nature trails (22km) in Matara-Sinharaja FR

have been maintained by the FD during this quarter. Further, BOQs, drawings and bid documents were completed to improve following nature trails.

- Anagimala Ella (0.3km) in Galle-Sinharaja FR
- Dawatagala (8km), Dothulugala (4.5km), Wedilunuguhawa (3km), Deenston (2km) and
 Alugallena (6km) in Kandy Knuckles FR

BOQs and drawings were completed to improve Pitadeniya and Deanston Circuit Bungalows in Knuckles FR

The design work and preparation of cost estimates for Galwila office and quarters for proposed Eco-Park has been completed. These proposed buildings will also strengthen the protection capacity of the FD. PMU planned to call bids for these construction during the early part of April 2018.

2.5.2 Progress of DWC activities

DWC was conducted a 03-day workshop at Girithale Training Canter (NWRTC) on 'Developing comprehensive proposals for Nature-Based Tourism Development'. The target group was Park Wardens from 20 NPs, relevant Additional Directors (ADs) and Section Heads of the Head Office. Further, DWC is expected to develop 25 comprehensive proposals on Nature-Based Tourism in selected NPs. The design work and preparation of cost estimation for Galwila office and quarters' complex has been completed. PMU has planned to call bids for these constructions during the early part of April 2018.

2.6 Component 3(c) - Institutional Capacity and Investment Capability of DWC and FD

The sub-component is supporting to strengthen the institutional capacity of two key implementing agencies; Forest Department and Department of Wildlife Conservation. It finances activities to improve skills and capacity for adaptive and effective management of PAs.

2.6.1 Progress of FD activities

Design consultancy to improve Sri Lanka Forestry Institute (SLFI) was awarded to the selected consultancy firm. The Inception Report of the consultancy was submitted to the PMU by the service provider and it has been accepted. Concept Design and Environment Screening Report was also submitted and PMU has made comments on that. It is expected to complete this consultancy by first week of May 2018. ESCAMP expects to offer the renovation and construction consultancy immediately after completion of the design consultancy.

Nine Double Cabs were purchased for the Department through ESCAMP funding. This procurement was handled by the PMU. Further, 33 Motor Cycles were also purchased for the Beat and Range offices to facilitate their field works. Fifty-five (55) Desktop computers and 23 Laptop computers were also provided to increase the institutional capacities of the Department. Bids to procure 100 GPSs for the Department was recalled and the procurement is on-going. FD expect to strength the field monitoring capacities using GIS technology in the future.

2.6.2 Progress of DWC activities

Design consultancy to improve National Wildlife Research and Training Center (NWRTC) was awarded to the selected consultancy firm. Its first milestone, the 'Inception Report' of the consultancy was submitted to the PMU. The report was reviewed by the PMU with the examination of DWC and provided the comments on the report. According to the comments made, the report was revised by the service provider and it was accepted by the PMU. Concept Design and Environment Screening Report will be submitted to the PMU by first week of April 2018. It is expected to complete the consultancy by the first week of May 2018. Selection of capable experts to develop Curriculum for NWRTC is in progress and it is expected to offer the consultancy parallel to renovation & construction phase of NWRTC.

With the ESCAMP assistance, the DWC has recommended nine-month Diploma Course in Wildlife Management for Wildlife Rangers to enhance their capacity through the NWRTC.

This course offers with the collaboration of University of Colombo for which 27 Rangers were enrolled. The academic part of the diploma includes lectures, practical component, field training and assignments are coordinated by the University of Colombo. Practical sessions were held at selected NPs. The diploma course was completed by May 2018.

The 'WILDLANKA' Annual Symposium, an annual event will be held for 2018 with the part funding support of ESCAMP. Currently, DWC collects the Research Papers for the Symposium. DWC is doing the awareness creation on this symposium through newspaper advertisements and via it's website. Also a flier has been sent for relevant public and private institutions to collect research papers.

Five Double Cabs were purchased for the Department through ESCAMP funding. This procurement was handled by the PMU. Also, DWC expects to procure some office equipment including computers by May 2018 and the technical guidance of Department's Procurement Committee.

2.7 Component 4 - Project Management

The finalized Management Information System (MIS) of the PMU has been installed. Account Department of the PMU is entering the required data into the system under supervision of the service provider. The PMU requested Management Services Department to create the positions such as Community Development Specialist, Internal Auditor, Senior Financial Officer, Social Development Officer and Management Assistant. The required paper advertisement was published by the Ministry of Mahaweli Development and Environment. However, the PMU expects to fill all these vacancies in the second quarter 2018. With effect from 8th February, 2018 the PMU has been relocated to a new location with an improved surrounding in Battharamulla. Its new office is on the second floor of the 'Sampathpaya Building'.

4.3 Procurement challenges

- (i) Unexpected delays when finalizing the Procurement Plan 2018 by both implementing agencies Initially, PMU planned to finalize the Procurement Plan for FD and DWC by 31st January 2018. However, there were unexpected delays due to internal issues of both agencies. Limited knowledge of the District level staff on procurement procedures was the main issue. Therefore, the expected date was delayed by 2 months (new deadline was 31st March 2018).
- (ii) Lack of knowledge related to the procurement process, procedures of the Implementing agencies Regional and District level officials of the Implementing Agencies are still not fully confident on carry out required field level procurements in line with the WB guideline and even with the government procurement guidelines. Therefore, further training, guidance from PMU and close monitoring is required. Apart from that, due to the low procurement ceiling stipulated by the government procurement guidelines for Regional Procurement Committees resulting, most of the filed level procurements also to be attended by the Head Office.
- (iii) Hiring a Procurement Specialist for Project Management Unit This position of Procurement Specialist is critical to support to the PMU to provide technical inputs to develop a systematic procurement plan, to improve the same in line with the WB guidelines and also to guide procurement staff in the PMU and Implementing Agencies.

5.0 Financial Management

5.1 Progress of FM actions such as submission of IUFRs, WAs, internal and external audits, fund transfers, field reviews and findings, etc.

IUFR and the Withdrawal Application for the quarter ended 31/12/2017 were submitted to the WB Colombo Office on 06th February 2018 to obtain the clearance. Accordingly, IUFR was cleared by Colombo office on 21st February 2018.

6.2 Summary of findings of field reviews

Most of the activities proposed within the protected areas of both Departments will not result in irreversible/considerable environment damage/concerns, and most of the activities can be managed in a comprehensive manner by implementing EMPs. However, in a few locations it is essential to manage possible social safeguard concerns arising from the above activities.

7.0 Monitoring and Evaluation

Project monitoring and evaluation (M&E) will serve to monitor and report on implementation progress, identify gaps that require corrective actions, and assess and report on project results. The results of the project should monitor through a Result Framework. Based on the Results Framework in the Project Appraisal Document (PAD), the PMU has developed a M&E Framework to the project. A discussion on the draft copy of this framework was held with the participation of responsible officials of PMU and WB. PMU should revise the framework based on the comments received from WB and send for approvals.

PMU has developed monitoring indicators for each proposal to evaluate the implementation progress. PMU has also drafted physical progress monitoring formats for selected activities which are included in Action Plan 2018 and sent both Departments to track the quarterly progress. Field monitoring plan for 2018 will be finalized and shared with key relevant senior officials of both implementing agencies.

The PMU together with the World Bank has conducted the training on 'Management Effectiveness Tracking Tool' on 20th February 2018 at Sampathpaya, Baththaramulla with the participation of 55 trainees from both Departments. The main objective of the training was to awareness creation on METT and to train attendees on filling each section of the METT. It will facilitate PA Managers to identify needs, constraints and priority actions to improve the effectiveness of protected area management. Further, outputs of this tool will produce baseline values for indicators related to 3(a) sub-component as well.

7.1 Status of establishment of baseline

Data collection tools of baseline for sub-component 2(a) were finalized. PMU expects to commence the data collection by end of April 2018 and it has planned to complete the assessment by end of May 2018. Baseline Assessment on sub-component 2(b) has planned to conduct during May and June 2018. The data collection tools on this assessment have been drafted by the component coordinator and shared with PMU staff for their comments. The filled forms of the METT are receiving from the project sites and the indicator values related to 3(a) sub-component will be calculated as its baseline values.
