The Democratic Socialist Republic of Sri Lanka has received a credit from the World Bank towards the cost of Ecosystem Conservation and Management Project, and intends to apply part of the proceeds of this credit to payments under the Contract for Construction of Proposed Buildings and Infrastructure Development in Field Training Centre of Sri Lanka Forestry Institute Inamaluwa, Sri Lanka.
- 2. The Chairman, Project Procurement Committee(PPC) on behalf of the Ecosystem Conservation and Management Project of the Ministry of Mahaweli Development and Environment now invites sealed bids from eligible and qualified bidders for construction of Proposed Buildings and Infrastructure Development in Field Training Centre of Sri Lanka Forestry Institute Inamaluwa for the Forest Department. The estimated cost is Rs.200 Million exclusive of VAT. The scope of work consists of civil works in Twenty-Five (25) buildings of the Inamaluwa Field Training Centre including Mechanical and Electrical works as described in Drawings, Specifications, Environmental Management Plan and the Bill of Quantitates.

The construction period is approximately 365 days.

- 3. Bidding will be conducted through the National Competitive Bidding (NCB) Procedure.
- To be eligible for contract award, the successful bidder shall not have been blacklisted and shall meet the following qualification criteria;
- The bidder should have registered with the CIDA (formerly known as ICTAD) as Grade C-3 or above in the Specialty of Buildings Construction.
  - Average annual volume of construction work performed during the last five years shall be at least Rs.300 million.
  - The minimum amount of liquid assets and/or project specific credit facilities exclusive of any advance payments which may be made under this contract shall not be less than Rs.50 million.
- 4. The method of payment will be in cash to the Project Accountant, Eco System Conservation and Management Project.

Completed bids in duplicate inserted in separate envelopes marked as "Original" and "Copy" and sealed, should be enclosed in one envelope with the contract number and the Title of Construction written on the top of envelope which should be sent to the address given below by registered post on or before 02-05-2019 at 11.00 a.m. The Bids shall also be deposited in the Tender Box kept at the Project Management Unit, Eco System Conservation and Management Project, "Sampathpaya", No.82, Rajamalwatta Road, Battaramulla. Late bids will be rejected. Bids will be opened soon after closing of bids in the presence of the bidders' representatives who choose to attend.
- 7. Site Visit and Inspection will be held on 09-04-2019 at 10.00 a.m. Pre-Bid meeting will be held on the same day (09-04-2019) at 02.00 p.m at the Inamaluwa Filed Training Center premises.
- P Bids shall be valid up to 04.10, 2019.
- All bids shall be accompanied by a Bid-Security issued by a Commercial Bank, accompanied The Central Bank. The amount of Bid Security shall be Rupees (Rs. 2,000,000.00) only as per the format attached and bidding document. The Bid Security shall be valid up to 31.10.2019. Any bid not accompanied by a valid bid security will be rejected.
- 10. Bidders must provide the PCA 3 form (Public Contract Act of 1987) along with their Bids.
